## Editor's Introduction

Welcome to the inaugural issue of the Oil & Gas, Natural Resources & Energy Journal (ONE J, which replaces Oklahoma Bar Association Energy and Natural Resources Newsletter. We expect ONE J to become a preeminent peer-reviewed energy and natural resources publication. As with the Newsletter, ONE J is co-sponsored by the Energy and Natural Resources Law Section of the Oklahoma Bar Association.
