SIR: In compliance with your verbal request of Saturday last, I have the honor to enclose, herewith, a tabular statement exhibiting the sales, within certain periods, in the Chickasaw cession at the graduated prices.

In preparing the enclosed, it was necessary to use the utmost despatch, in order to have it ready this morning, as you requested; and, consequently, it was impracticable to make the requisite examinations and calculations as carefully as they would have been made had more time been allowed. It is believed, however, that the enclosed is sufficiently accurate to answer general purposes, and it is hoped that it may be found satisfactory.
