Editor's Introduction

Welcome to the first Issue of Volume 5 of the Oil and Gas, Natural Resources, and Energy Journal, the current Editorial Board's first publication. This light summer issue contains an Energy Litigation Update from outstanding oil, gas, and energy attorney Mark Christiansen and one student-authored comment from Daniel Tavera.

The first piece is a Litigation Update by Mark Christiansen, which he originally presented at the 2018 Kuntz Conference on Natural Resources Law and Policy. The Litigation Update is comprehensive, examining changes regarding non-operator and operator rights, computation of gas royalty payments, and the resolution of oil and gas lease termination claims. Additionally, the Update contains developments regarding the rejection of midstream service contracts in bankruptcy proceedings and the Extended Horizontal Well Development Act, formerly the Shale Reservoir Development Act.

The second piece is a student-authored comment from Daniel Tavera. The comment explores the different ways bankruptcy courts may classify oil and gas leases and how the disparate treatment may result in a party losing its property interest in the event of bankruptcy. The author describes how a court's failure to treat an oil and gas lease as a conveyance of a real property interest may leave the debtor free to assume or reject the interest during bankruptcy proceedings. The comment explains how this result might deter potential investors in oil and gas ventures.
