IN MEMORIAM JOSEPH F. RARICK, 1921-1989

This issue of the American Indian Law Review is dedicated to our sponsor, Dr. Joseph F. Rarick, who died January 14, 1989. The list of Dr. Rarick's accomplishments and honors is long and distinguished. During World War II he served in Patton's Third Army. Dr. Rarick received his bachelor's degree with highest honors in political science from the University of Illinois in 1943 and his Juris Doctor in 1948, also from the University of Illinois. He received his master of law in 1949 and his doctor of science of law in 1956, both from Columbia.

Dr. Rarick came to the University of Oklahoma College of Law in 1953. In 1967 he was named a David Ross Boyd Professor and an Alfred P. Murrah Professor in 1984. Dr. Rarick was acknowledged as the leading Oklahoma authority on Water Law and was designated by the state legislature as Oklahoma's "Father of Water Law." Dr. Rarick began his long association with the *American Indian Law Review* in 1977 as its faculty adviser. From 1980 until the time of his death he was the

faculty sponsor of the American Indian Law Review.

Dr. Rarick, or "Roaring Joe" as he was affectionately known to his colleagues and students, was one of those rare individuals who was able to take on ten different projects at once and manage to get them all done. Despite the hectic pace he maintained he always found time to explain to a perplexed first-year Property student the significance of the year 1066, and to debate the ramifications of the foreclosure of mortgages of Indian lands under the authority of state courts with his third-year Indian Land Titles students.

Forever etched in the memories of hundreds of students who have passed through the doors of the University of Oklahoma College of Law will be the first time we saw him. For some it may have been in the Library where our investigation of a mysterious clanging noise led us to a man resplendent in a white jumpsuit bedecked with silver Indian jewelry, researching assiduously. For others it may have been when we saw him riding his Moped up to the Law Center or when we peeked into his classroom to see where all the noise was coming from.

Those of us who were fortunate enough to have taken one of his classes will not forget his intense respect and love of the Law that he projected during his lectures. We who have been lucky enough to have served under his guidance as staff members of this *Review* will always remember him as a champion of those ideals we have endeavored to promote.

With the passing of Dr. Rarick the profession he so greatly enriched has lost one of its giants, and we who had the opportunity to learn from him have lost a teacher and a friend. It is with great humility that we dedicate this issue of the *American Indian Law Review* to the memory of Dr. Joseph F. Rarick. We will miss him.
