In Memoriam

Professor E. Dwight Morgan

Professor E. Dwight Morgan, Class of '50, died April 26, 1985, in Norman Regional Hospital after an extended illness. Born May 18, 1924 in Shawnee to Mr. and Mrs. John Harmon Morgan, he was a 1941 graduate of McLoud High School.

He joined the Army Air Corps as a flight instructor and navigator. Following discharge from the service in 1944, Morgan received a B.A. from Oklahoma State University, an LL.B. from the University of Oklahoma in 1950, and an LL.M. in 1951 from the University of Michigan.

He taught at the University of Nebraska from 1951 to 1954 and at the University of Alabama from 1954 to 1966 before joining the faculty at the OU College of Law in 1966.

Morgan was a member of Saint Michael's Episcopal Church, the Order of Coif, the Oklahoma Bar Association, and an honorary member of the Order of Barristers. He also was a member of the U.S. Court of Military Appeals, a legal adviser to the Commission on Judicial Reform for the state of Alabama, and a member of the Aircraft Owners and Pilots Association.

Survivors include his wife Margie; a daughter, Susie Fuller of Berry, Ala.; a son, Chris Morgan of Oklahoma City; his mother, Mrs. Gladys Morgan of Shawnee; a brother, Harmon Morgan of Lubbock, Texas; and five grandchildren.

The family has designated the OU College of Law's Dwight Morgan Scholarship Fund, 300 Timberdell Road, Norman, Oklahoma, 73019, as appropriate for expressions of sympathy.
