SIR: I have the honor to transmit, for the information of the House of Representatives, an estimate of the appropriations proposed to be made for the service of the year 1842, amounting to - \$24,424,358 95

1. The appropriations for the service of the year 1842, made by former acts of Congress, including arming and equipping the militia, civilization of Indians, revolutionary claims, revolutionary pensions under the act of June 7, 1832, claims of the State of Virginia, unclaimed pensions, relief of the several corporate cities in the District of Columbia, and public debt - - - 1,572,900 00
2. The existing appropriations which will be required to be expended in the year 1842, amounting to - - - 10,543,120 19
3. There is also added to the estimates a statement of the several appropriations which will probably be carried to the surplus fund at the close of the present year - - - 267,908 45
4. In a note is separately specified the amount which it is estimated will be required in 1842 for the redemption of Treasury notes - - - - - 7,000,000 00
