Second Auditor's Office, November 21, 1842.

Sir: Herewith I transmit a statement showing the amount of money annually disbursed out of the fund appropriated by the act of the 3d March, 1819, for the civilization of the Indian tribes, from the date of the act down to the 8th of February, 1842.

This statement has consumed a great deal of time and labor in its preparation, and furnishes all the information called for by you which the records and papers of this office afford.
