SIR: In obedience to the act of Congress approved 1st May, 1820, I have the honor to communicate herewith a statement of such appropriations for this department as had been appropriated for the service of the War Department prior to the passage of the act of 3d March, 1849, creating the Department of the Interior, showing the balances of appropriations on the 1st July, 1851; the appropriations made for the fiscal year ending 30th June, 1852; the repayments and transfers in same time; the amounts drawn by requisition from the treasury in same period, and the balances on the 1st July, 1852, with such appropriations as have been carried to the surplus fund.
