DEPARTMENT OF THE INTERIOR,  
*December 14, 1854.*

SIR: I have the honor to submit herewith, supplemental estimates of funds required for the service of this department for the fiscal year ending 30th June, 1856, based upon information received since the regular annual estimates, heretofore presented, were made up and laid before Congress.

These funds, it will be perceived, are needed for the Indian service, and for surveying the public lands upon the Pacific coast and in remote territories of the country, from which it was impossible to receive such intelligence as to enable the department to take any definite action respecting them at an earlier day.

The present superintendent, Palmer, has allowed accounts to the amount of \$6,524 77, up to the 30th June last, of this nature, and reports that there are others justly due. He recommends that an appropriation be made to pay such as are not yet paid, and to reimburse the general expense fund of that Territory for such as he has liquidated heretofore from that fund.

At present it is deemed most proper to ask for the appropriation heretofore usually made for Indian purposes in Texas.</p>

FORT CLARK, TEXAS, November 1, 1854.

SIR: The report which accompanied my estimate for running the new boundary line between the United States and Mexico, expressed the belief that it would be sufficient to complete the running of the line. For reasons not anticipated at that time, and given below, I am compelled to change this opinion :

1. The storm in Matagorda bay and on the coast of Texas, which has delayed us for upwards of a month, and thereby greatly increased our expenses; by this delay we will be thrown on the plains in the winter, and will have our stock of animals so crippled as to make it necessary to suspend operations for several months in order to refit and replace it. My expectation of reaching the mild Pacific slope, west of the Del Norte, before the season of the northers, is entirely frustrated.

2. The yellow fever which raged with so much violence on our southern coast, did not permit us to escape its malign influence; and the bills for medical services and other incidental expenses have been largely increased.

3. The worn-out condition of the animals, and the almost total decay of other property, of the old boundary commission, upon which I counted largely for transportation. This state of things exists not from neglect, but from effects of time. In truth, the rigors of the two last campaigns have so unfitted our stock of animals for any further service, that even with light loads, slow travel, and full forage, their condition remains unimproved.

In view of these circumstances, I deem it prudent to correct my former statement, and, in order to meet these unexpected demands, have the honor to request an additional sum of \$71,450, for the following purposes :

For the purchase of 150 mules, at \$60.....	\$9,000 00
For the purchase of 30 horses, at \$100.....	3,000 00
For one-half forage for the above animals, at prices of the country, inclusive of transportation.....	16,450 00
For camp and garrison equipage.....	3,000 00
For pay of officers, laborers and teamsters, for 8 months, period of time necessary for the prolongation of the work, consequent upon various delays, &c.....	24,000 00
For subsistence, transportation, commutation of rations, &c.	16,000 00
<b>Total.....</b>	<b>71,450 00</b>

And I ask for this sum at this time, because of the necessity of having that amount appropriated at the coming session; any action of the subsequent Congress will be too late: the work before then must be either closed or suspended.

GENERAL LAND OFFICE, *December 4, 1854.*

SIR: On the 19th of October last I had the honor of submitting to you an estimate of appropriations necessary for surveying the public lands, &c., during the fiscal year ending June 30, 1856, with the exception of the surveying districts of California, Oregon, New Mexico, Washington, Kansas, and Nebraska.

Since that period, estimates have been received from the surveyors general of California, Oregon, and New Mexico; and although none have been received from Washington Territory, nor from Kansas and Nebraska, I deemed it requisite to estimate for those surveying districts, and to present them to you as proposed to be submitted to Congress.
