SIR: In compliance with the direction of the third section of the act of 20th April, 1836, entitled "An act to carry into effect the treaties concluded with the Chickasaw tribe of Indians on the 20th October, 1832, and the 24th May, 1834," I have the honor to transmit herewith a detailed statement, prepared by the Register from the treasury books, showing the sums credited and the amounts charged on account of the several trusts created under those treaties during the year 1855. No lands ceded by them are reported to have been sold during the year.
