SIR: I have the honor to enclose a copy of a letter dated the 13th ultimo, from the Acting Commissioner of Indian Affairs, apprising me of an error in the estimates transmitted to the House of Representatives, on the 16th ultimo, for fulfilling treaties with the Chickasaws, and to request that the correction therein suggested may be made.

SIR: In the additional estimates transmitted to you with a communication from this office of the 13th instant, an omission occurred, to which I have the honor to call your attention, and request that you communicate the fact to the Committee on Finance of the Senate and the Committee of Ways and Means of the House of Representatives.

It is as follows: The amount estimated for the expenses of the Chickasaw delegates should be \$1,766 instead of \$892, the charge of one of the delegates having been overlooked.
