TREASURY DEPARTMENT, *May 1, 1860.*

SIR: In compliance with the act of April 25, 1836, entitled "An act to carry into effect the treaties with the Chickasaw Indians of October 20, 1832, and May 24, 1834," I have the honor to transmit herewith a detailed statement prepared by the Register from the books of the treasury, showing the sums credited and the amounts charged on account of the several trusts created under those treaties during the year 1859.
