The annual statement showing balances of appropriations, &c.

DECEMBER 24, 1860.—Laid upon the table and ordered to be printed.

DEPARTMENT OF THE INTERIOR, *December 20, 1860.*

SIR: I have the honor to transmit herewith the annual statement required by the act of May 1, 1820, prepared by the Second Comptroller of the Treasury, showing balances of appropriations standing upon the books of this office to the credit of this department on the 1st of July, 1859, the amounts appropriated by Congress for the service of the fiscal year ending June 30, 1860, including repayments and transfers of appropriations, and the aggregate amounts applicable to the service of said fiscal year; also the amounts drawn from said appropriations or carried to the surplus fund from July 1, 1859, to June 30, 1860, and the balances remaining in the treasury at the last-named date.
