MESSAGE

FROM THE

PRESIDENT OF THE UNITED STATES,

IN RELATION TO

*Appropriations and expenditures connected with the Indian service.*

JUNE 25, 1866.—Referred to the Committee on Appropriations and ordered to be printed.

*To the House of Representatives :*

I transmit herewith a report from the Secretary of the Interior communicating in part the information requested by a resolution of the House of Representatives of the 23d of April last, in relation to appropriations and expenditures connected with the Indian service.

SIR: I have the honor to enclose herewith, as a partial response to a resolution of the House of Representatives of the 23d of April last, copies of a communication of the Commissioner of Indian Affairs of the 21st instant, and statement of the Register of the Treasury showing the amount of all moneys on hand July 10, 1865, for the support of the various Indian tribes and for other purposes connected with the Indian service, also the entire amount which has been expended since that time up to the 20th of April, 1866, and the various heads of appropriations under which the moneys were drawn, together with the amount now on hand applicable to such service.

Congress did not authorize the department to employ the additional clerical aid required to enable me to answer more fully the resolution at this time. The accompanying papers are, nevertheless, submitted for transmission to the House of Representatives. They are as complete as it is practicable to render them with the clerical force at my disposal, without detriment to the indispensable current business of the department.

SIR: Referring to office reports of the 2d and 7th ultimo relative to a resolution passed by the House of Representatives on the 23d April last, I have to state that this office is in receipt of a statement furnished by the Hon. Secretary of the Treasury showing the money on hand in his department on the 10th day of July, 1865, applicable to the support of the various Indian tribes and for other purposes connected with the Indian service; the appropriations from July 10, 1865, to April 20, 1866, and the repayment and transfers during the same time; the total expenditures between the two last-mentioned dates, and the balance on hand on the 20th April last.

This statement is a full response to said resolution except that it does not show the particular objects for which the expenditures have been made; and as no response has thus far been made to the request for additional clerical force to enable the department to respond to that part of the resolution, it is presumed that the House does not deem the matter of sufficient importance to provide the ten additional clerks asked for in my report of the 7th.

I therefore enclose herewith a copy of the statement furnished by the Treasury Department, and respectfully suggest that it be submitted to the House of Representatives as a partial response to said resolution as well as the one passed on the 4th instant; and if that part of the resolution not responded to by said statement is deemed of sufficient importance to provide the necessary clerks to enable this department to furnish the desired information, that their attention be again called to the difficulties in the way of a prompt response, and the absolute necessity for additional clerical force to perform the labor, as set forth in office report of the 7th ultimo.
