LETTER

FROM

THE SECRETARY OF THE INTERIOR,

TRANSMITTING

Claim of A. J. Smith for supplies furnished to the Sheep-Eaters, a northern band of Shoshone Indians.

JANUARY 26, 1871.—Referred to the Committee of Claims and ordered to be printed.

Washington, D. C., January 26, 1871.

SIR: I have the honor to submit to Congress herewith, for such action thereon as shall be deemed proper, the claim of A. J. Smith for goods and provisions furnished by him to the Sheep-Eaters, or northern band of Shoshone Indians, in Montana Territory, in January, 1870.

The report of the Commissioner of Indian Affairs, dated the 21st instant, transmitting the claim to this Department, is also herewith inclosed.

SIR: By the inclosed papers, which I have the honor herewith to submit, it appears that in January, 1870, while the Sheep-Eaters, or northern band of the Shoshone tribe of Indians, were encamped near Virginia City, Montana Territory, they received at the hands of A. J. Smith certain goods and provisions to the value of \$707 05, and agreed to pay for the same "out of the first annuities allowed by the United States."

Mr. Smith now presents, through the superintendent of Indian affairs for Montana, by whom it is approved, a claim against the Government for the amount above stated, together with certificates and affidavits to substantiate the said claim.

These Indians, having no treaty relations with the United States, are

not recipients of annuities; and there are no funds on hand from last year's appropriations that can be applied to the payment of Mr. Smith's claim.

I have no doubt, however, that the goods and provisions were actually furnished, as stated in the papers herewith inclosed, although without any knowledge or authority on the part of this office, and would respectfully recommend that the claim be laid before Congress for such action in the premises as shall be deemed proper.

I hereby acknowledge to have received the articles specified above from A. J. Smith, at Virginia City, January 4, 1870; and I hereby agree that the amount of the same is to be paid back to him out of the first annuities allowed to my band by the Government of the United States.

therein \$95 cash paid by me for freighting said goods, &c., to the camp of the Sheep-Eaters, or northern band of the Shoshone tribe of Indians, (for whom said goods were furnished,) and also for necessary expenses in freighting the same.
