*An appropriation to pay certain Indian depredation claims now pending before Congress.*

SIR: I have the honor to transmit herewith a copy of a report, dated the 6th instant, from the Commissioner of Indian Affairs, in relation to certain Indian depredation claims now pending before Congress, and which are described in the accompanying schedule.

The Commissioner recommends that an appropriation be asked for the payment of these claims.

I will remark that this Department has no knowledge of the facts connected with these claims beyond what is contained in the Commissioner's report and the papers heretofore submitted to Congress.

SIR: Referring to the provisions of the seventh section of the Indian appropriation act, approved May 29, 1872, I have the honor to call the attention of the honorable Secretary to the fact that since the 27th November, 1871, I have reported upon 46 cases of alleged depredations by Indians, in which claims for damages had been filed in this office, (exclusive of the claim of Mrs. Fanny Kelly, which has already received

favorable action by Congress,) recommending in each case a specific allowance. The total damages alleged by the claimants in these 46 cases amount to \$121,050.70. The total amount recommended for allowance is \$58,815.10. During the same period of time a large number of claims have been examined and reported on adversely to the Department. Each of the claims favorably reported on, a schedule of which accompanies this letter, was examined by myself. The presentation of the case was to conform strictly to the regulations which governed in respect to depredation claims under the act of 1834, prior to the passage of the act of July 15, 1870. The evidence has been scrutinized with the utmost care, and is believed to establish incontrovertibly the fact of depredation and the amount of damage in each case in the full sum recommended for allowance. No more searching and severe examination could be made under any system of regulations or restrictions that might be adopted, and I feel therefore justified in suggesting to the Department that I be allowed to re-affirm under the provisions of the act of May 29, 1872, and without further consideration, the action of this office in respect to each and all of the 46 claims named in the accompanying schedule. Should this be held admissible, I would respectfully recommend that Congress be asked to make an appropriation in the aggregate amount of \$58,815.10 for the payment of the several claimants whose claims have thus been recommended for allowance.
