TOPEKA, KANSAS, April 5, 1871.

*To the honorable the Secretary of War:*

The undersigned, commissioners detailed from the Army under the act of February 2, 1871, to examine and audit the claims of the State of Kansas against the United States for reimbursement of moneys expended in defense against rebel invasion in 1864, having completed the examination and audit required by the statute, respectfully report thereon, as follows:

The total amount of indebtedness assumed by the State arising from the sources of expenditure in question is \$500,000. It does not appear that this amount, reimbursement for which is sought by the State, has been actually paid out in cash from the State treasury. The State, however, formally assumed the responsibility of this class of indebtedness, known as the "Price raid claims," but only to the amount of the figures above given, authorizing the issue of interest-bearing scrip therefor, pledging payment of the amount of its face out of "any moneys received from the United States in liquidation of the expenses" under consideration. (Specimens of this scrip are annexed hereto.)

These claims have been made the subject of thorough examination at different times by various State commissioners.

They were first examined by a board of State officials under the provisions of acts of the legislature approved February 10, 1865, and February 26, 1866. Fraudulent and fabricated vouchers to a considerable amount were afterward discovered to have been issued and to have passed inadvertently the examination of this board.

A special examining committee was provided for by act of the legislature, approved February 26, 1867, to consist of three disinterested persons appointed by the governor to revise the work of the previous board. This committee, sworn to the faithful performance of its duties, appears to have made a thorough investigation and to have discovered and rejected the defective vouchers alluded to.

A committee of the legislature also subsequently investigated the whole subject, recommending to favorable consideration the labors of the examining committee, and stating that there were additional accounts which had not been considered by either of the previous boards, or which, if they had been considered by the examining committee and rejected, might have been so disposed of for want of sufficient proof, and not upon their merits. They, therefore, recommended a third board, to be provided for by law, to examine this class of claims, and admit them upon due substantiation.

Legislative provision in this direction was thereupon made by an act approved February 16, 1869, creating a board to consist of three State officials to examine the vouchers submitted to them of the character described. This board performed the duties assigned to them and made report thereof.

By the statute of February 10, 1865, the legislature provided that the following classes of claims should be audited: those for services of the militia called out to repel the Price raid, those for supplies and material and transportation furnished to or taken by the State militia thus called out or by the regular troops of the United States; those for damages to property done to the same; and, generally, demands of any character growing out of any transaction for the use and benefit of the militia or troops of the United States during the invasion or the attempted invasion of the State by Price's army in the autumn of 1864; and including further demands pertaining to the defense of the State against the Indians in the same year.

Besides the foregoing, claims were to be audited for horses killed in battle, captured by the enemy, or unavoidably lost on account of the Price-raid campaign, including damages to fences, real estate, &c., destruction of crops and personal property of citizens. To these comprehensive groups of claims the act of February 27, 1866, added another: claims for damages done to property or losses sustained by citizens of Kansas by the operations of the rebel army under Price.

The amount of the claims passed by these State boards, as reported by the State auditor to the commissioner, (see Exhibit A,) is as follows:

So much of this amount as is not in excess of \$500,000 the State of Kansas claims to be due it on settlement with the United States, and vouchers for the whole were submitted to the examination of the commissioners.

The act of February 2, 1871, the regulations prescribed by the Sec-

retary of War, and the order of appointment of the commissioners are appended, marked, respectively, B, C, and D.

The law and the regulations for the government of the commissioners allow only the examination and audit of such claims as may properly come under the heads of enrolling, equipping, arming, subsisting, transporting, and paying the State militia, limiting allowances to a period not exceeding thirty days, and for the time when the militia were actually in service for the purpose of repelling rebel invasion or suppressing the rebellion in Kansas; and this, providing that the call of the governor was made, and the service of the troops had, upon the request of the local department commander, or with his consent or concurrence, and providing, further, that the troops for whom allowances are to be made shall have performed military service under the orders and in co-operation or concert with the United States military authorities in Kansas.

Thus the present commission had no legal warrant for the examination and audit of claims of any nature whatever for damages; that is to say, for damages occasioned by depredations upon, or destruction of, private property by our own or by the enemy's troops. The acquisition of necessary supplies and their reduction to the public possession, and conversion to the public use by forced requisitions of United States officers, and their distribution or issue, in proper manner, to the troops, is a different matter from the wanton trespasses of soldiers upon private property, or its waste, or unauthorized, or prohibited conversion to individual use. In the latter case there is no responsibility for payment on the part of the United States. In the former, upon due proof of all the essential facts, the property taken may be paid for. This distinction the present commission have observed in their audit.

Every account, voucher, and roll has been inspected, and the proof accompanying submitted to careful examination. Where the prices have been in excess of what the Government, as far as could be determined, would have had to pay for the same articles or services at the period named, the commission have reduced the prices to the proper standard. Such accounts as seem not to carry with them sufficient warrant for the expenditure of the public money called for have been rejected.

The commissioners, believing it to be the intent of the statute to provide for the admission of properly authenticated claims for the usual and proper expenses for the pay and maintenance of the militia force as called out in the manner, and rendering service under, the circumstances described, including allowances for the usual provisions for the health and comfort of the troops, for the proper and necessary means for carrying on military operations, or for the local defense, have embraced accounts pertaining to these branches of expenditure, as will be noticed in the accompanying abstracts, under the general heads named in the statute.

The commissioners find the balance due the State of Kansas from the United States to be \$337,054 38, classified as follows:

The total number of militia troops called into service and performing duty was, including officers and men, fifteen thousand one hundred and eleven, distributed into organizations, as seen in the abstract of paying.

Herewith is submitted the journal of the proceedings of the commissioners, which sets forth principally the following matters: First, that the commission qualified according to law, and was duly organized on the 15th of March, 1871, at Fort Leavenworth; second, that it adjourned to Topeka and placed itself in communication with the governor and State authorities, and that it continued its sessions from time to time until April 5, 1871, when it adjourned *sine die*.

Herewith is also transmitted an official copy of the report of the adjutant general of Kansas, showing the history of the call and of the services of the militia in question.

The testimony taken before the commissioners, and the correspondence with the State authorities, also accompany this report.
