The payment of the Montana Indian war claims of 1867.

DECEMBER 9, 1874.—Referred to the Committee on War-Claims and ordered to be printed.

The Secretary of War has the honor to transmit to the House of Representatives, report of Maj. George Bell, commissary of subsistence, the officer charged with the disbursement of the appropriation of March 3, 1873, for payment of the Montana Indian war claims of 1867.

Washington, D. C., October 28, 1874.

SIR: I have the honor to submit the following report:

By Special Orders, No. 60, War Department, Adjutant-General's Office, Washington, March 22, 1873, in addition to my present duties, I was "charged with the disbursement of the fund for the payment of the Montana Indian war claims of 1867, appropriated by act of Congress, approved March 3, 1873," and reported upon by Colonel and Inspector-General James A. Hardie, United States Army; to be paid to the persons "severally entitled thereto by a disbursing officer under the direction of the Secretary of War," and by your instructions, "under such regulations as may be prescribed by the Second Comptroller."

Payments were made on Treasury certificates, properly authenticated by the Third Auditor and Second Comptroller. For the convenience of claimants, funds were placed in the subtreasury, New York City, and checks to the order of the proper parties, designated by the Second

Comptroller, drawn when necessary. In all cases an obedience to the law and orders was rigidly complied with.

The desired accountability for all the disbursements was forwarded to your office for the final action of the accounting officers of the Treasury.

Total amount of appropriation, \$513,343; amount disbursed, \$512,223.13; balance in subtreasury awaiting unpaid certificates issued, \$1,119.87.
