*Estimate of funds required for the survey of Indian reservations during the fiscal year ending June 30, 1876.*

For this amount, for the survey of Indian reservations, and subdividing portions of the same, one hundred and ninety-one thousand eight hundred and twenty dollars: *Provided*, That the sum of one hundred and fifty thousand dollars thereof, or so much thereof as may be necessary, be applicable to the payment of such surveys executed prior to the end of the fiscal year ending June thirtieth, one thousand eight hundred and seventy-five.

*Colorado River reserve.*

For surveys of boundaries of Colorado River reservation in Arizona, as extended by Executive order of November 16, 1874..... \$5,000

*Devil's Lake reserve.*

For subdivision into 40-acre tracts of a portion of the Devil's Lake Indian reservation in Dakota, per treaty, February 19, 1867, (Statutes at Large, vol. 15, p. 505)..... 10,000

*Old Sioux and Winnebago reserves.*

For completing the subdivision of the old Sioux and Winnebago reserves in Dakota, 22 townships into 160-acre tracts, and 14 townships into 40-acre tracts ..... 28,820

*Yankton and Winnebago reserves.*

For completing the subdivision of the Yankton reserve in Dakota (20 townships) and the Winnebago reserve in Nebraska (4½ townships) ..... 3,000

*Indian Territory.*

For completing the surveys of Indian reservations in the Indian Territory ..... 80,000

*Fort Hall reserve.*

For the subdivision of a portion of the Fort Hall reservation in Idaho into 160-acre tracts, and boundary-lines..... 10,000

*For surveys of sundry Indian reservations, and subdividing portions thereof in—*

Oregon.....	\$25,000
California .....	10,000
Washington Territory .....	15,000
New Mexico Territory .....	5,000
