Estimates of funds required for the survey of Indian reservations during the fiscal year ending June 30, 1875.

For this amount for the survey of Indian reservations and sub-dividing portions of the same, three hundred and ninety-two thousand six hundred and eighty dollars: *Provided*, That the sum of two hundred and fifty thousand dollars thereof, or so much thereof as may be necessary, be applicable to the payment of such surveys executed prior to the end of the fiscal year ending June 30, 1874.
