KANSAS INDIAN RESERVATION.

RESOLUTION

THE LEGISLATURE OF KANSAS.

IN REFERENCE TO

The sale of Kansas lands.

FEBRUARY 16, 1874 .- Referred to the Committee on Public Lands and ordered to be printed.

Whereas there is now pending before the Congress of the United States a bill providing for the sale of the Kansas Indian reservation on three years' time, to actual settlers, at the present appraised value; and

Whereas said appraised value is, in the opinion of the settlers on and others interested in said lands, 25 to 50 per cent. too high; and

Whereas there is also pending before said Congress of the United States a substitute for said bill, providing for a re-appraisement of said lands: Therefore be it,

Resolved, That our Senators and Representatives in said Congress are hereby respectfully requested to use their influence to secure the passage of said substitute, providing for a re-appraisement of said Kansas lands and their sale to actual settlers, as provided in said substitute.

Resolved, That the secretary of state is hereby instructed to furnish to each of our Senators and Representatives in Congress a copy of these resolutions.

I hereby certify the above is a correct copy of H. C. Res., No. 16, which was passed by the house of representatives on the 3d day of February, 1874.
