SIR: I have the honor to transmit herewith, in duplicate, an estimate of appropriations required to meet deficiencies in the appropriations for the Indian service for the fiscal year 1881 and prior years. In submitting this estimate, it has been sought to itemize so far as practicable, the expenditures made, and that idea has been carried out so far as relates to deficiencies therein named which occurred prior to the present fiscal year.

The largest deficiencies previous to the current year are in the appropriations for the "transportation of Indian supplies." The subject of insufficient appropriations for this purpose has repeatedly been brought to the attention of Congress and its committees. An estimate for the purpose, for deficiencies for the fiscal years 1879 and 1880, was presented to Congress at its last session, and the assurance of the Committee on Appropriations of the House was given that the same should be duly considered, but no action seems to have been taken thereon.

A large proportion of the indebtedness for transportation is due to contractors who have faithfully and promptly performed the service, under the orders of the department, and I deem it not only unjust to the claimants to delay payments, but unwise, inasmuch as such a course undoubtedly tends to increase the rates which the department is obliged to pay for this service.

The item of \$25,000 for the support of the Utes in Colorado is necessary for the reason that heretofore the accumulated interest arising on their principal of \$500,000 to their credit in the Treasury has been used for their support; but under the provisions of the act approved June 15, 1880, ratifying the Ute agreement the sum of \$60,000 was drawn out of the Treasury and paid to them per capita. Increased expenditures for subsistence have also been made for said Indians upon the recommendation of the Ute Commission, which, together with the increased number of Indians which it was and now is necessary to feed, pending the negotiation of the recent treaty with them, and their removal to their new lands, has exhausted the fund appropriated for their support during the current year.

An additional appropriation of \$50,000 for the support of the Arapahoes, Cheyennes, Apaches, Kiowas, Comanches, and Wichitas is required, for the reason that the amount appropriated for their support for the current fiscal year, \$305,000 (being \$45,000 less than the sum estimated for), is inadequate to supply them with the necessary articles required for their care and subsistence. There are 10,022 Indians at the two agencies to be subsisted under this appropriation, viz, Cheyenne and Arapahoe 5,899, and Kiowa 4,123, and even with the sum asked for, partial rations only can be supplied. If a full ration for each person for an entire year was supplied, estimating the cost at 15 cents, it would involve an expenditure of over a half million dollars. The regular appropriation of \$290,000 made for said Indians for the fiscal year 1880 proved to be insufficient, and a deficiency appropriation was made by Congress for that year of the sum of \$80,000, making a total of \$370,000.

The amount recommended (\$5,000) for the support of Nez Percés of Joseph's band, is based upon the fact that the appropriation of \$15,000 for the current year has proved to be deficient; \$25,000 was appropriated for the fiscal year 1880, \$10,000 of which was a deficiency. They number 344 souls.

Under the title of "Contingencies Indian Department," the sum of \$7,500 is recommended for the balance of the fiscal year. This amount is absolutely necessary, owing to exigencies of the service requiring extraordinary expenditures, rendered necessary by reason of the number of Indian delegations who have visited this city since July last, on business for their respective tribes.

The item of \$1,000 for "traveling expenses of Indian inspectors" for the balance of the fiscal year, is actually necessary, owing to the large number of agencies necessary to be visited and inspected during the year. The sum provided for the current year, is \$5,000 for five inspectors, which amount, it is calculated, will be exhausted by April 1, next.

The other items in the estimate not particularly referred to, are sufficiently explained in detail therein, to enable Congress to understand the object of the appropriations, and I respectfully recommend that these estimates meet with your approval, and be transmitted to Congress for the action of that body.
