Washington, December 6, 1882.

SIR: I have the honor to transmit herewith, in compliance with the first clause of section 445, Revised Statutes, the accompanying abstract showing the nature, character, and amount of all claims presented to the Secretary of the Interior since April 8, 1882, under laws or treaty stipulations, for compensation for depredations committed by Indians, with his action thereon, "and the evidence upon which this action was based."

By the practice of the department prior to April, 1882, each claim, as it was passed upon, was transmitted by separate communication to Congress, and hence this report embraces only claims finally acted upon since that date.
