NOTE.—Claims for fees of witnesses marked with * are presented by holders of certificates issued by commissioners of United States circuit court for the western district of North Carolina, showing the sum due to each witness for attendance on behalf of the United States. The witnesses were not paid by the marshal (as he admits), and they sold their certificates, giving receipts to the purchasers. The claims are stated in the names of the holders of the certificates. In view of the provisions of section 3477 of the Revised Statutes, it is held that even if money were now available the accounting officer would not be authorized to pay these holders or assignees. But the claims are herein submitted for the consideration of Congress. In the case of Jane W. Hume, executrix, there is no affidavit that the witnesses were paid. The former holder of the certificates, Robert W. Hume, is dead, and the only proofs of payment are the receipts on the certificates.
