SIR: I have the honor to acknowledge the receipt of a copy of a resolution of the House of Representatives, dated the 27th of May, as follows:

Resolved, That the Secretary of State, the Secretary of War, the Secretary of the Treasury, the Attorney-General, the Postmaster-General, the Secretary of the Navy, and the Secretary of the Interior be required, respectively, to furnish this House with a full and complete schedule of all trust funds in their custody, from whom and when received, to whom due, where held, and amounts of same; the amount of the unexpended balance of the Geneva award available for the payment of the judgments of the Court of Alabama Claims, and all other unexpended balances in the custody of either of the above-named officers of the Government; the estimated amount required for repayment to importers of excess of customs dues, and any and all claims, of whatever nature, estimated and ascertained, which may within the fiscal year become a liability against the Treasury of the United States.

In response I transmit herewith reports from the chiefs of Bureaus of this Department, containing the information called for by the resolution so far as it relates to this Department.

THE SPEAKER OF THE HOUSE OF REPRESENTATIVES.

SIR: In compliance with your verbal instructions of this morning, I have the honor to return herewith copy of resolution of the House Committee on Ways and Means calling for a complete schedule of all trust funds in the custody of this Department, and the amount of all unexpended balances, as well as the estimated amount required to pay all claims of whatever nature which may become a liability against the Treasury within the present fiscal year.

I have to report that from the latest information furnished to me—that is, under date of June 5, 1886—there was in the hands of the eighteen United States pension agents the sum of \$0,918,195.16 of the Army pension fund and \$181,812.19 of the Navy pension fund.

There is in the Treasury of the United States, as shown by the records of this office at this time, \$64,063.56 of Army pension funds and \$151,733 Navy pension funds, balances of these appropriations respectively.

It is safe to assume that the claims against these appropriations will entirely exhaust them before the close of the present fiscal year. There is also at the present time an unexpended balance of \$419,372.92 of the appropriation for the arrears of pensions made by the act of Congress approved March 3, 1879.

It is estimated that at least \$5,000 will be required to pay the claims accruing on account of arrears during the remainder of the present fiscal year. It is proper to state, in this connection, that this appropriation is not deposited in the Treasury at the end of the fiscal year, it being made continuous by the act of March 3, 1879.

Of the appropriation for the various items in the conduct of this office, I am advised by Mr. Brock, the assistant chief clerk, that on this date the unexpended balances are as follows:

Salaries, \$311,555.64; salaries of special examiners, \$60,959.95; for the investigation of matters pertaining to Pension Bureau, \$92,462.27; per diem of additional special examiners, \$72,452.23.

The claims against these several items during the remainder of the fiscal year are estimated to be as follows:

Salaries, \$160,000; salaries of special examiners, \$17,000; per diem for detailed clerks, \$13,000; per diem for special examiners, \$14,000.

I am not aware that there are any trust funds, so far as the Pension Office is concerned, within the custody of the Secretary of the Interior.

SIR: I have the honor to acknowledge the receipt, by reference from the Department for report, of a resolution of the House of Representatives relative to certain trust funds, &c., and in reply thereto have to state that this office has no trust funds in its custody.

There are certain outstanding liabilities chargeable to the appropriations for the fiscal year 1886, the amount of which cannot be at present stated owing to the fact that the accounts thereto pertaining have not been adjusted. The liabilities of the Government for the past fiscal year are provided for by the appropriations made, and a large surplus will be turned into the Treasury. Contracts for surveying the public lands have been approved for \$90,988, and additional ones amounting to \$24,409 are still pending. If the contracts pending are approved, the estimated liability for surveying will be \$115,397. State fund accounts, accounts of special agents, registers and receivers, swamp indemnity, and other miscellaneous accounts outstanding will, it is estimated, approximate \$100,000 additional for the fiscal year 1886.

I have the honor to reply that the amount appropriated for the use of the Bureau of Education for the year ending June 30, 1885, was \$49,397.60.

Of this there have been expended \$48,753.98. The outstanding liabilities amount to \$81.75. The balance is \$561.87.

SIR: I have the honor to acknowledge the receipt, by your reference for report on the 9th instant, of a copy of resolutions of the House of Representatives, dated May 27, 1886, calling upon the Secretary of the Interior to furnish the House with a full and complete schedule of all trust funds in his custody, from whom and when received, to whom due, where held, and amounts of same; all unexpended balances in his custody, and the estimated amount of any and all claims, of whatever nature, estimated and ascertained, which may within the fiscal year become a liability against the Treasury of the United States.

In compliance with the requirements of said resolution, as understood by this office, I inclose herewith the following detailed statements, namely:

(1) Statement of moneys due to various Indian tribes, under treaty stipulations, *not* on deposit in the United States Treasury, upon which interest at 5 per centum per annum is annually appropriated by Congress, said interest being under the control of the Secretary of the Interior. These interest-bearing principals have never been appropriated by Congress.

(2) Statement of funds held in trust by the Government in lieu of investment, under the control of the Secretary of the Interior, for the benefit of various Indian tribes, bearing interest at 4, 5, and 6 per centum per annum up to and including May 31, 1886, *on deposit* in the United States Treasury.

(3) Statement of invested tribal funds, held in trust by the Secretary of the Interior (Treasurer of the United States, custodian), being non-paying State stocks, the interest on which is annually appropriated by Congress; also abstracted bonds, the interest upon which is annually provided for by Congress.

(4) Statement of State bonds held in trust by the Secretary of the Interior (Treasurer of the United States, custodian), the interest on which is regularly paid by said States.

(5) Statement of United State bonds (Union Pacific Railroad) held in trust by the Secretary of the Interior (Treasurer of the United States, custodian) for Indian tribes, the interest on which is paid semi-annually by the Secretary of the Treasury.

(6) Statement of receipts on account of sales of Indian lands, under the control of the Secretary of the Interior, on deposit in the United States Treasury, *not* drawing interest, on hand May 31, 1886.

(7) Statement of all trust funds in custody of the Commissioner of Indian Affairs, on deposit with Treasurer of the United States.
