DEPARTMENT OF THE INTERIOE, OFFICE OF INDIAN AFFAIRS, Washington, February 11, 1886.

SIR: I have the honor to invite your attention to the fact that this office is not in possession of accurate statistics regarding the number of Indians, located upon the several Indian reservations in the States and Territories of the United States, and that it is my opinion, if a correct census of all the tribes and bands could be obtained, a large saving of money would thereby be secured by the Government in the preparation of estimates for appropriations for the Indian service, submitted to Congress for its action from time to time.

In view of the expenses incident to the obtainment of a correct census of all the tribes and bands, and for the reason that this office has not at its disposal any moneys applicable for the purpose named, I respectfully recommend that Congress be requested to appropriate the sum of \$5,000 for the object specified, to be expended under your direction.
