SIR: I have the honor to be in receipt, by your reference of the 22d instant with direction to forward the estimate called for, of a communication addressed to you by Hon. R. T. Pettigrew, United States Senate, in which he states that he has introduced a bill to increase the salary

of the Commissioner of Indian Affairs and the Assistant Commissioner.

He further states that this bill can be incorporated in the Judicial, Executive and Legislative appropriation bill if an estimate for it from the Department be transmitted to the Committee on Appropriations in regular order.

He further requests that such an estimate be prepared and forwarded at once, the increase of these salaries to be at \$1,000 per annum, each.

In compliance with the request of the Department, I have caused to be prepared the necessary estimate, herewith inclosed, and inasmuch as the bill introduced by Mr. Pettigrew (S. 3908; see Congressional Record of the 23d instant, page 5396) contemplates in addition the increase of salary of the financial clerk of the Indian Office, I have also estimated for an increase at the rate of \$250 per annum for said financial clerk, with the recommendation that the same be forwarded to the chairman of the Senate Committee on Appropriations through the honorable the Secretary of the Treasury.

The letter of Senator Pettigrew is respectfully returned herewith.
