SIR: On October 18, 1886, this office submitted a report on depredation claim No. 899 of Richard F. Blinn, amount, \$2,400; and pursuant to Department letter of October 22, 1886, the claim, with all the

PERRYSBURGH, WOOD COUNTY, OHIO.

March 15, A. D. 1881.

SIR: Your favor of the 8th instant, in reply to my letter of the 28th ultimo, informing that the deprecation claim of Richard F. Blinn, filed February 23, 1871, for \$2,400, was on the 1st day of May, 1873, reported to the honorable Secretary of the Interior with a recommendation that the same be allowed for \$1,200, that it can not be paid except by special act of Congress, came duly to hand, which I have the honor to acknowledge with my sincere thanks.

Allow me to say that I do *not* clearly understand why, when the amount of loss sworn to by the claimant, sustained by the witness, is \$2,400, only \$1,200 was recommended to be allowed, the Cheyenne admitting the deprecation.

The claimant, since the filing, is deceased, leaving brothers and sisters; his heirs at law, father and mother, surviving. The mother, since claimant's death, is also deceased.

I am authorized as appears in the power of attorney filed with the claim.

The heirs reside in this vicinity.

In order to obtain special act of Congress for the payment of any sum of money allowed in the premises I suppose I shall need certified copies to attach to the petition for such special act, and wish to prepare and present the same at next session of Congress through the Representative of this district; and provided any sum of money is allowed and so authorized to be paid, to speedily collect and distribute the same in pursuance of law.

Will you therefore please kindly furnish such copies, and any blanks for my convenience, consistently and in harmony with the rules and usages of the office? and very greatly oblige, very respectfully,

SIR: In compliance with the terms of the seventh section of the act approved May 29, 1872, entitled "An act making appropriations for the current and contingent expenses of the Indian Department, and for fulfilling treaty stipulations with various Indian tribes, for the year ending June 30, 1873, and for other purposes," I have the honor to transmit herewith papers in the claim of Richard T. Blynn, amounting to \$2,400, for compensation on account of depredations committed by Cheyenne Indians.
