The Comptroller feels bound by the decision of the Supreme Court in the case of the United States vs. Sebastian Kaufman (96 U. S. Reports, 567) to certify the claims herein reported for the refunding of taxes illegally collected which have been allowed by the Commissioner of Internal Revenue.
