Estimate of appropriation by Secretary of the Interior for certain employés at the Navajo Agency.

JULY 6, 1886.—Referred to the Committee on Appropriations and ordered to be printed.

SIR: I have the honor to transmit herewith, for the consideration of Congress, copy of letter of Secretary of the Interior of this date submitting an estimate of appropriation for pay of employés at the Navajo Agency, in New Mexico, for the fiscal year ending June 30, 1887, as follows:

One carpenter, \$900 per annum; one teamster, \$660 per annum.

SIR: In accordance with the provisions of section 2 of the act of July 7, 1884 (23 Stat., 254), I have the honor to transmit herewith, for presentation to Congress, copy of a letter of 2d instant from the Commissioner of Indian Affairs, inclosing an item of appropriation in the sum of \$1,560 providing for the payment of certain service at the Navajo Indian Agency in New Mexico, for which the regular appropriation was not found sufficient; which item he recommends may be placed in the general deficiency bill for the current fiscal year.

The recommendation of the Commissioner has the concurrence of this Department.

The papers are furnished in duplicate for presentation to both the Senate and House of Representatives, and I have the honor to request that they may be forwarded as early as practicable.

SIR: I have the honor to recommend that the inclosed item, providing for a teamster, at \$660 per annum, and a carpenter, at \$900 per annum, for the Navajo Agency, in New Mexico, be transmitted to Congress for insertion in the bill making appropriations for general deficiencies for the current fiscal year, the regular appropriation for services of employes for this fiscal year not being sufficient to supply the necessities of the agency.
