LETTER FROM THE ACTING ATTORNEY-GENERAL, TRANSMITTING LIST OF JUDGMENTS NOT HERETOFORE REPORTED TO CON-GRESS OR APPROPRIATED FOR, RENDERED IN FAVOR OF CLAIMANTS SINCE THE PASSAGE OF THE ACT OF MARCH 2, 1895, PROVIDING FOR THE PAYMENT OF CERTAIN JUDG-MENTS OF THE COURT OF CLAIMS IN INDIAN DEPREDATION CASES.

## DEPARTMENT OF JUSTICE, Washington, D. C., December 30, 1895.

SIR: Pursuant to the provisions of section 8 of the act of Congress entitled "An act to provide for the adjudication and payment of claims arising from Indian depredations," approved March 3, 1891, I have the honor to transmit herewith a list of judgments, not heretofore reported to Congress or appropriated for, rendered in favor of claimants since the passage of the act of March 2, 1895, providing for the payment of certain judgments of the Court of Claims in Indian depredation cases.

A judgment rendered on February 18, 1895, in favor of George W. Thompson and Lonny Horn, for \$2,455, which is not included in the list herewith transmitted, has not heretofore been reported to Congress, but has been certified to the Secretary of the Treasury for payment, under the provisions of the act entitled "An act making appropriations to supply deficiencies in the appropriations for the fiscal year ending June thirtieth, eighteen hundred and ninety-five, and for prior years, and for other purposes," approved March 2, 1895.
