STR: In obedience to the provisions of the act of the 6th May, 1822, entitled "An act to amend an act, entitled 'An act to regulate trade and intercourse with the Indian tribes, and to preserve peace on the frontiers,' approved the 30th March, 1802," I have the honor to transmit you, herewith, copies of all such accounts as have been rendered to this office, by persons charged or trusted with the disbursement or application of money, goods, or effects, for the benefit of the Indians, from the 1st January to the 1st September, 1822, as per schedule of the same, marked S. No. 2, together with a list of the names, marked S. No. 1, of all persons to whom money, goods, or effects, have been delivered, within the same period, specifying the amount and object for which they were intended, and showing who have been delinquent in forwarding their accounts.

The delay in rendering these statements has been unavoidable, from the retard in many of the returns, owing to the distance of some of the agents, and the pressure of business in the office.
