TRANSMITTING

A communication from the Attorney-General requesting authority to pay claims of certain deputy marshals.

FEBRUARY 9, 1894.—Referred to the Committee on Appropriations and ordered to be printed.

TREASURY DEPARTMENT, *February 8, 1894.*

SIR: I have the honor to transmit herewith for the consideration of Congress a communication from the Attorney-General of the 5th instant, asking that authority be granted him by Congress to pay the claims of certain deputy marshals named therein, amounting to \$1,542, for services at the opening of the Iowa and the Sac and Fox Indian agencies in Oklahoma, from the unexpended balance of the appropriation of \$20,000 made by the deficiency act of July 28, 1892 (27 Stat., p. 299), for "Deputy marshals in Oklahoma."

SIR: You are respectfully requested to forward the following statement in relation to the claims of deputy marshals for services at the opening of the Iowa and the Sac and Fox agencies. On page xxv of the Report of the Attorney-General, 1892, reference is made by Attorney-General Miller to the amounts due to such persons. As no action was taken for providing for the payments, I renew the application made by my predecessor that authority be granted to pay the claims below stated, in the sum of \$1,542, out of the unexpended balance of the \$20,000 appropriation made by Congress, p. 299, 27 Stat. L.
