Washington, D. C., January 8, 1895.

SIR: I have the honor to acknowledge the receipt of a copy of the following resolution of the Senate, under date of December 22, 1894, to wit:

Resolved, That the Attorney-General be, and he is hereby, directed to furnish to the Senate, as soon as practicable, a full and complete list of all judgments rendered by the Court of Claims in Indian depredation cases up to January 1, 1895, giving in tabulated form the number, date, and amount of each judgment and the name of each judgment creditor; and if paid, giving the date of such payment; if certified for payment, giving the date of such certification; if motion for reopening or rehearing or new trial therein has been filed, giving the date when so filed.

and, complying with the terms of said resolution so far as possible, I herewith submit a tabulated statement of all judgments rendered by the Court of Claims in Indian depredation cases up to January 1, 1895, giving the number, date, and amount of each judgment, and the name of each judgment creditor, together with the date of certification for payment or motion for new trial in each case where such action has been taken.

The date of payment of judgments which have been paid is not of record in this office, such payment having been made by the Treasury Department.
