Washington, D. C., December 27, 1894.

SIR: On November 23, 1894, the Department of the Interior states that for several years appropriation has been made for the employment of a special United States attorney for the Mission Indians of Southern California, which was omitted from the appropriation for the current fiscal year, adding the following language:

The present attorney for these Indians has rendered valuable service. He has now important business in hand for settlement, and the conditions and circumstances surrounding these 28 bands or villages of Indians will doubtless render the continuation of such service advisable for several years to come. It is especially important that these services shall continue through the present and the next fiscal years. I therefore recommend that Congress be asked to make an appropriation of \$1,000 for each of these years.
