LETTER FROM THE ATTORNEY-GENERAL, SUBMITTING, IN RESPONSE TO SENATE RESOLUTION OF JUNE 2, 1896, A LIST OF JUDGMENTS RENDERED IN THE COURT OF CLAIMS IN FAVOR OF CLAIMANTS ON JUNE 1, 1896.

DEPARTMENT OF JUSTICE,
Washington, D. C., June 2, 1896.

SIR: I am to-day in receipt of a resolution of the Senate of June 2, 1896, of which the following is a copy, to wit:

Resolved, That the Attorney-General be directed to transmit forthwith to the Senate a list of all final judgments rendered in Indian depredation claims since the 21st day of May, 1896, being the date of the last report to Congress.

In compliance with the terms of said resolution I herewith submit a list of judgments rendered in the Court of Claims in favor of claimants on June 1, 1896, no other judgments in favor of claimants having been rendered since the date named in the resolution.
