TRANSMITTING

A communication from the Quartermaster-General asking for an additional appropriation for horses for cavalry and artillery.

SIR: I have the honor to transmit herewith for the consideration of the Committee on Appropriations, House of Representatives, communication, dated March 6, 1896, addressed to the Secretary of War by the Quartermaster-General of the Army, relative to amount needed for "horses for cavalry and artillery," and to request that the \$24,000 asked for in excess of the \$25,000 allowed be included in the deficiency bill, to supply at once the cavalry and artillery regiments with needed remounts.

SIR: I have the honor to invite your attention to communication from this office of January 4, 1896, submitting deficiency estimate for \$49,000 to supply cavalry and artillery horses for the Army for the balance of the present fiscal year, and to the fact that but \$25,000 was allowed upon this estimate in the urgent deficiency act recently passed.

As the amount of this deficiency appropriation has already been exhausted, and there are on hand in this office requisitions for horses requiring the expenditure of the entire amount as asked for, viz, \$49,000, I have respectfully to request that you will submit the matter to the attention of the chairman of Committee on Appropriations of the House of Representatives, with request that the \$24,000 already asked for in excess of the \$25,000 allowed be included in the deficiency bill, to supply at once the cavalry and artillery regiments with needed remounts.

SIR: I have the honor to report that, of the \$80,000 appropriated for the purchase of cavalry and artillery horses for the Army during this fiscal year, \$61,564.89 has already been expended, leaving but \$18,435.11 available, with six months of the fiscal year yet to run.

Thus far the purchase of 518 horses has been authorized, and the balance in hand will supply about 130 additional horses at existing prices, making a total of about 650 horses, which can be supplied from the entire amount appropriated.

No horses have as yet been supplied this fiscal year for the Eighth and Tenth Cavalry, while many troops of the other cavalry regiments and several light batteries of artillery have not as yet made requisition for remounts.

The records of this office show that during the past three fiscal years an average of about 1,000 horses have been required to supply the cavalry and artillery service; so that it is fair to assume that about 350 horses will yet be needed to remount the troops.

To supply these horses at present prices will require about \$49,000, and it is respectfully recommended that the attention of Congress be invited to the inclosed deficiency estimate, with request that the necessary funds be appropriated to keep the cavalry and artillery service equipped for efficient service.

Estimates of appropriations required for the service of the fiscal year ending June 30, 1896, by the Quartermaster's Department, United States Army.

Horses for cavalry and artillery:

Purchase of horses for the cavalry and artillery and for the Indian scouts and for such infantry and members of the Hospital Corps in field campaigns as may be required to be mounted, and the expenses incident thereto: *Provided*, That the number of horses purchased under this appropriation, added to the number on hand, shall not at any time exceed the number of enlisted men and Indian scouts in the mounted service, and that no part of this appropriation shall be paid out for horses not purchased by contract after competition duly invited by the Quartermaster's Department and an inspection by such Department, all under the direction and authority of the Secretary of War (R. S., p. 206, sec. 1133; R. S., p. 221, secs. 1270, 1271; Revised Army Regulations 1895, p. 135, par. 972; Feb. 12, 1895, vol. 28, p. 661, sec. 1).. \$49,000
