LAND WITHIN THE CHICKASAW CESSION.

MESSAGE

FROM

THE PRESIDENT OF THE UNITED STATES,

IN RELATION TO

Lands sold which lie within the Chickasaw cession, &c.

JUNE 9, 1840.

Referred to the Committee on the Public Lands.

To the House of Representatives:

I herewith submit a report from the Secretary of the Treasury, in relation to certain lands falling within the Chickasaw cession, which have been sold at Chocchuma and Columbus, Mississippi, and invite the attention of Congress to the subject of further legislation in relation to them.

SIR: I have the honor to lay before you the enclosed papers, received from the Commissioner of the General Land Office, in relation to conflicting claims arising from the sale of certain locations falling within the Chickasaw cession, in order that they may be submitted to the action of the House of Representatives.

GENERAL LAND OFFICE, June 5, 1840.

SIR: After the definitive establishment of the boundary line between the Chickasaw and Choctaw cessions, it was found that certain lands falling within the former cession had been sold at Chocchuma and Columbus, Mississippi.

• Document A, herewith, exhibits the particular tracts thus sold, and the amount of the purchase-money paid to the receivers at Chocchuma and Columbus. This document was submitted to the Commissioner of In-

dian Affairs, with a letter from this office, of the 28th December last (No. 1), requesting that he would "cause an examination and comparison to be made, and apprise me of the result, extending up to the last returns of locations to your [his] office, as to whether there are any of the tracts, embraced in said abstract, covered, in whole or in part, by any locations," &c.

A copy of the reply from that officer, under date of the 1st instant (No. 2), is herewith submitted, as also a copy of the document B, accompanying the same, indicating certain locations conflicting with a portion of the aforesaid sales.

The particular tracts which are covered by the locations, as indicated by document B, are fully exhibited in document C, herewith, showing, also, the areas of those tracts, and the amount of purchase-money.

In reference to the locations indicated in document B, it will be seen that the Commissioner of Indian Affairs states that they "have not been approved, and the action of" that "office thereon will not be had until the census of the Chickasaw nation, taken under the aforesaid treaties, has been deposited in" that "department."

In order that the titles of the purchasers of said lands at Chocchuma and Columbus, which were subsequently found to be within the Chickasaw cession may be quieted, and the Chickasaws indemnified, I recommend that the matter be submitted to Congress, to the end that provision may be made by law—

1. For giving effect to the aforesaid sales, where there may be no conflict, and which amount to \$3,647 39, purchase-money, and that an appropriation be made, of that sum, for the benefit of the Chickasaws—the amount, as stated, having been paid into the district offices in the Choctaw country.

2. That provision, also, be made by law for the issuing of patents for any such sales, now covered by Indian locations, where a decision may be made *adverse to the validity of such locations*, and that an appropriation, at the same time, may be made for the benefit of the Chickasaws, of an amount equal to the purchase-money which it shall be found was paid into the district land offices at Chocchuma and Columbus, on account of any such sales.

GENERAL LAND OFFICE, December 28, 1839.

SIR: I enclose, herewith, an abstract, on four folio pages, exhibiting sales of certain lands at Chocchuma and Columbus, Mississippi, which, after the definitive establishment of the boundary line between the Chickasaw and Choctaw cessions, are found to be within the former cession.

I propose submitting this document to the Secretary of the Treasury, to the end that the subject may be brought to the attention of Congress,

with a recommendation that the sales aforesaid be legalized, so that patents can issue for them as in ordinary cases of sales at those places; and, further, that an appropriation may be made, for the benefit of the Chickasaws, of a sum of money equal to that paid into the district land offices at Chocchuma and Columbus for said lands—in all, about 8,205 $\frac{4}{5}$ acres, amounting to \$10,334 $\frac{7}{8}$.

As shown by the abstract, the areas of the portions of a few tracts, in all, of an inconsiderable number of acres, have been estimated, the contents of such portions not appearing on the plats in this office.

Before proceeding farther in the premises, however, I have to request that you will cause an examination and comparison to be made, and apprise me of the result, extending up to the last returns of locations to your office, as to whether there are any of the tracts embraced in said abstract, covered, in whole or in part, by any location; and that, at the same time, you will advise me of the views of the department as to the propriety of the measure contemplated by this office; or, if any other be deemed more expedient for the settlement of the matter, I request to be informed of it.

You will please return the abstract.

SIR: I return, herewith, the abstract of sales of certain lands at Chocchuma and Columbus, Mississippi, which, after the definitive establishment of the boundary line between the Chickasaw and Choctaw cessions, are found to be within the former cession.

The accompanying document exhibits the locations made for Chickasaw Indians, who claim, under the treaties of 1832 and 1834, with that tribe, which conflict, in whole or in part, with the sales made by land officers at Chocchuma and Columbus. These locations have not been approved, and the action of this office thereon will not be had until the census of the Chickasaw nation, taken under the aforesaid treaties, has been deposited in this department. No examination has been made of approved locations, because the facility of doing so is greater at your office than with mine, on account of your possessing complete tract-books, indicating townships and ranges in consecutive order.

It is to be inferred, from the large number of Chickasaws claiming reservations, that some of the locations have not been received at this office; and it may possibly happen that some of them have been placed on the tracts designated on your abstract.

This department does not observe any impropriety in the course proposed by you, provided proper provision be made for bona fide conflicting claims. Very respectfully, your most obedient servant,
