THE ATTORNEY-GENERAL,

TRANSMITTING,

IN RESPONSE TO RESOLUTION OF THE SENATE OF FEBRUARY 25, 1899, A LIST OF ALL JUDGMENTS IN FAVOR OF CLAIMANTS IN INDIAN DEPREDAATION CASES RENDERED SINCE THE DATE OF THE LAST APPROPRIATION FOR THE PAYMENT OF SUCH JUDGMENTS, JULY 7, 1898.

Washington, D. C., February 27, 1899.

SIR: I am in receipt of the following resolution of the Senate, under date of February 25:

Resolved, That the Attorney-General be directed to transmit to the Senate a list of judgments rendered by the Court of Claims in favor of claimants in Indian depredation cases requiring an appropriation by Congress.

In compliance with the terms of said resolution I herewith transmit a list of all judgments in favor of claimants in Indian depredation cases rendered by the Court of Claims since the date of the last appropriation for the payment of such judgments, July 7, 1898.

The list herewith transmitted includes the judgments heretofore reported to the House of Representatives and contained in House Document No. 183 of this session, with such corrections as have been made necessary by more recent action of the court.
