SIR: The following list comprises all the persons employed in connexion with the extension of the United States Capitol, and the repairs of the congressional library, referred to in the inquiries contained in the resolution of the Senate, a copy of which I had the honor to receive under cover of your letter of the 17th instant.

Z. W. Denham, clerk, at a salary of \$1,200 per annum. His duties are, to keep all the books and accounts pertaining to the extension of the Capitol and the repairs of the congressional library, to keep records of all the correspondence connected with the work, to prepare all the pay-rolls of the workmen, and to perform all other duties usually pertaining to a general clerkship.

William J. Fitzpatrick, temporary clerk, employed during the working season to assist in paying the workmen, making out the pay-rolls, copying and recording bills for materials, &c., at \$2 25 per day.

Clement L. West, temporary draughtsman, to assist in preparing detail drawings for the several departments of the work, at \$3 per day.

August Schonborn, temporary draughtsman, with similar duties, at \$2 25 per day.

Daniel Kernan, messenger, at \$1 50 per day.

None of these officers have any extra compensation, nor perquisites of office beyond the amounts above stated.
