WILLIAM B. CREWS,
[To accompany bill H. R. No. 4.]

JANUARY 22, 1850.

Mr. Thomas, from the Committee of Claims, made the following

REPORT:

The Committee of Claims, to whom was referred the petition of William B. Crews, report:

That the papers show that petitioner served as a mounted volunteer in a rifle company, in the service of the United States, from 8th day of August, 1837, to 14th February, 1838, and has been paid only for two months and twenty days. The committee herewith report a bill to pay him for the remaining time he served, three months and fourteen days, and recommend its passage.

To the honorable the Congress of the United States, at its session of 1842.

The declaration and petition of William B. Crews, of Macon county, North Carolina,

RESPECTFULLY REPRESENTS:

That on or about the 8th day of August, 1837, he was mustered into the service of the United States, at Fort Butler, now Cherokee county, North Carolina, by Lieutenant Montgomery, as a mounted volunteer, where he served as a second corporal from then till about the 14th day of February, 1838, when he was discharged from the service in the company; that for two months and twenty days he has received his pay from Major Bennett, as will appear by reference to the books of the War Department, but for the remainder of the time which he served, amounting to about three months and fourteen days, he has received no compensation whatever; that he made application to the Secretary of War for his pay, to which he received, in answer, the letter which is hereunto appended, marked A, and prayed to be taken as a part of this petition; from which letter it appears that the accounting officers can only look to the muster rolls for the evidence of any such claim, and be governed by that only; that from the omission or neglect of some one, it appears the muster rolls of Major Paine (or his representative, Colonel Powell, the mustering officer) have never reached the department, as your petitioner is informed, and that the name of your petitioner does not appear for that time. Now, therefore, your

petitioner here proposes to supply that proof by the affidavit of Lieutenant John B. Dickey, which is hereunto appended, marked B, and prayed to be of this petition. And your petitioner would further represent that, inasmuch as the muster rolls of Colonel Paine are out of their proper file, your petitioner is wholly remediless, save only by some action which your honorable body may make in his behalf; that he is quite a poor man, with a family, and much needs the proceeds of all his labor, and that this is a claim which he thinks is justly due him by the government, and that an investigation of his case will show the equity and justice of his claim.

Your petitioner, for the reasons set forth in the premises, most respectfully requests that his petition may be heard, and that his pay may be awarded to him according to his service, as set forth in the premises; and your petitioner, as in duty bound, will ever pray, &c.

SIR: In answer to your letter of the 24th instant, with its enclosures to the Secretary of War, as referred to this office, I have the honor to state that the claim of William B. Crews has been again examined, and he is found to have been paid in full as a corporal of Captain J. Truit's company of mounted North Carolina militia, from 8th August to 31st October, 1837, \$101 13, and that his name does not appear on the rolls of the company, for its service from 1st November, 1837, to 18th July 1838, when it was discharged. And inasmuch as the accounting officers are governed by the muster roll, and that only, the depositions of John A. Hall and John B. Dickey are herewith returned.

This day came before me, J. M. Bryson, an acting justice of the peace in and for said county, John B. Dickey, and maketh oath in due form of law, and sayeth that he was a first lieutenant in a company of North Carolina volunteers, mustered into the service of the United States, under Isaac Truit, captain, and John A. Hall, second lieutenant, by Lieutenant A. Montgomery, of the United States army, on the 8th day of August, 1837, and that William B. Crews served in the said company of volunteers as a second corporal, from the 8th day of August, 1837, until the 14th day of February, 1838, or thereabout, and that he (Crews) was then dis-

charged from the company and from the service, and that he (Crews) has received pay for two months and twenty days' service, as will appear from the pay-roll, as per Major Bennett, at Fort Lindsey, North Carolina, and that if he (Crews) has received any other pay for his services, this affiant hath no knowledge of that fact, but that this affiant hath reasons to believe and does believe that through some neglect either of the mustering officer, the captain, or some other person to this affiant unknown, the said Crews hath received no other compensation whatever, and further this deponent sayeth not.
