Mr. HALE, from the Committee on Appropriations, submitted the following

REPORT.

[To accompany H. R. 10691.]

The Committee on Appropriations, to whom was referred the bill (H. R. 10691) making appropriations to supply deficiencies in the appropriations for the fiscal year ending June 30, 1898, and for prior years, and for other purposes, report the same back to the Senate with amendments, with a statement showing the amount of the bill as passed the House of Representatives and the amount as reported to the Senate, with the items of increase recommended thereto.
